## Article L. 151-11 du code de l'urbanisme

I.-Dans les zones agricoles, naturelles ou forestières, le règlement peut :

1° Autoriser les constructions et installations nécessaires à des équipements collectifs dès lors qu'elles ne sont pas incompatibles avec l'exercice d'une activité agricole, pastorale ou forestière du terrain sur lequel elles sont implantées et qu'elles ne portent pas atteinte à la sauvegarde des espaces naturels et des paysages ;

2° Désigner, en dehors des secteurs mentionnés à l'article L. 151-13, les bâtiments qui peuvent faire l'objet d'un changement de destination, dès lors que ce changement de destination ne compromet pas l'activité agricole ou la qualité paysagère du site. Le changement de destination est soumis, en zone agricole, à l'avis conforme de la commission départementale de la préservation des espaces agricoles, naturels et forestiers prévue à l'article L. 112-1-1 du code rural et de la pêche maritime, et, en zone naturelle, à l'avis conforme de la commission départementale de la nature, des paysages et des sites.

II.-Dans les zones agricoles ou forestières, le règlement peut autoriser les constructions et installations nécessaires à la transformation, au conditionnement et à la commercialisation des produits agricoles, lorsque ces activités constituent le prolongement de l'acte de production, dès lors qu'elles ne sont pas incompatibles avec l'exercice d'une activité agricole, pastorale ou forestière sur le terrain sur lequel elles sont implantées et qu'elles ne portent pas atteinte à la sauvegarde des espaces naturels et des paysages. L'autorisation d'urbanisme est soumise pour avis à la commission départementale de la préservation des espaces naturels, agricoles et forestiers.

Les changements de destination ont fait l'objet d'une fiche de renseignements communiquée à chaque commune, permettant aux élus locaux de recenser les changements de destinations effectifs. Cela dans le respect strict des critères du deuxième alinéa de l'article L151-11, à savoir : ne pas compromettre l'activité agricole ou la qualité paysagère, et disposer d'une capacité de réseaux et voirie à proximité immédiate du bâtiment (environ 100m).

Entre les mois de décembre 2022 et avril 2024, les retours réguliers des communes ont permis d'identifier 1470 changements de destination potentiels sur l'ensemble du territoire de CAUVALDOR.

Ces changements de destination potentiels, respectant les textes et renseignés au travers d'une fiche particulière, ne représentent pas l'enveloppe prévue dans le projet. En effet, cette enveloppe a été déterminée par ailleurs, sur la base des données ADS (permis pour réhabilitation avec changement de destination) et d'informations statistiques relevées auprès d'agences immobilières. Il a donc été constaté un rythme de 40 réhabilitations avec changement de destination par an (période de référence : du 1er janvier 2010 au 31 décembre 2021). La mobilisation de bâti existant proposée dans le projet est de répondre aux enjeux d'accueil de population, de mobilisation d'un bâti patrimonial, de maintien du taux de résidence secondaire et de diversification de l'offre de logement. Cela se traduit dans les objectifs du PADD par une mobilisation, pour la production de logements, du bâti existant à hauteur de 20%, soit entre 450 et 500 réhabilitations. Compte tenu de l'effort fait sur la mobilisation de la vacance (environ 9%), nous pouvons estimer le rythme de production de logements par changement de destination à 250, soit environ 25 par an. En additionnant à cela la part de changements de destination en hébergement touristique, le PLUi-H retient une valeur de 400 changements de destination pour la période du projet.

## 1 | Définition et présentation du document

Le changement de destination consiste à modifier l'affectation de tout ou partie d'un bâtiment. Il fait référence à une modification dans l'utilisation prévue d'un bâtiment tel que défini par les réglementations d'urbanisme locales. Par exemple, un bâtiment agricole peut être reconverti en un espace résidentiel.

Le présent document liste l'ensemble des changements de destination de la communauté de communes Causses et Vallée de la Dordogne, par commune. Chaque changement est identifié par un identifiant unique, une localisation (référence cadastrale, lieu-dit), une photo et une description succincte.
